RESOLUTION 11-2020

A RESOLUTION PROVIDING FOR MODIFICATIONS TO THE PROGRAM FOR PRETREATMENT OF NON-DOMESTIC CONTRIBUTORS TO THE MUNICIPAL WASTEWATER SYSTEM AND FOR THE REGULATION OF SUCH CONTRIBUTORS THROUGH THE ISSUANCE OF PRETREATMENT PERMITS, THROUGH ENFORCEMENT OF REQUIREMENTS, THROUGH MONITORING AND THROUGH REQUIRING USER REPORTING. A RESOLUTION MODIFYING ASSOCIATED PERMIT FEES AND LABOR FEES AND MODIFYING RESOLUTION 09-2020.

WHEREAS, the Municipal Sanitary Authority of the City of New Kensington desires to comply with the provision of the Federal Water Pollution Control Act (33 United States Code 1251, et seq.), the Environmental Protection Agency General Pretreatment Regulations (40 Code of Federal Regulations Part 403) and the Publicly Owned Treatment Works Penalty Law (Act No. 9 of 1992, 35 P.S. Section 752.1, et seq., effective April 26, 1992), as amended;

NOW THEREFORE, BE IT RESOLVED, by the Board of the Municipal Sanitary Authority of the City of New Kensington, Westmoreland County, Pennsylvania as follows:

PURPOSE AND POLICY

This Resolution sets forth uniform modifications to the program for regulating Direct and Indirect contributors into the wastewater collection and treatment systems of the Municipal Sanitary Authority of the City of New Kensington. These modifications enable the Municipal Sanitary Authority of the City of New Kensington to more fairly and equitably distribute pretreatment program costs through the distribution and implementation of fees. The charges will more aptly reflect use potential impact and strive to make the program self-supporting.

MODIFICATIONS

1: This resolution modifies Section 3 of The Municipal Sanitary Authority of the City of New Kensington's existing industrial treatment program by setting forth fees, by classification and flow range, said permitting fees to remain in place until further amended by subsequent resolution of the Board of Directors of The Municipal Sanitary Authority of the City of New Kensington. The new permit fee structure shall be:

LEGAL AND RELATED FEES:

Any and all legal fees for time allocated for pretreatment issues associated with any wastewater system of The Municipal Sanitary Authority of the City of New Kensington shall be charged said legal fees as the same arise (as incurred). Said rates to be charged are based upon an hourly rate of \$140.00 per hour plus photocopy fees .10 per page and mailing and other expenses, as incurred including but not limited to legal research fees of \$61.00 per hour.

2: The labor fee chart for the Fee Allocation System (Supplemental Form Number 1 (S1), as referenced in Resolution 03-6). The rates shall be effective until amended by future Resolution of the Board.


3: Any and all changes to classification or flow range shall be reported, within ninety (90) days of the change by a classified provider of waste into the wastewater collection and treatment system of The Municipal Sanitary Authority of the City of New Kensington. The purpose of this provision is to more fairly and equitably distribute pretreatment program costs and to require industrial pretreatment providers to notify The Municipal Sanitary Authority of the City of New Kensington of all changes that may impact permitting requirements.

This Resolution shall be in full force and effect immediately after its passage and approval by the Municipal Sanitary Authority of the City of New Kensington with the effective date of issuance of the fees per the terms of this Resolution of January 1, 2021.
